Welcome note by Chairman of the committee completed and discuss various plan of actions Student Grievance

1. Several students raised concerns about the lack of sufficient seating in the library during peak hours. The committee discussed possible solutions, including increasing seating capacity or implementing a time-slot system.

2. Complaints were received regarding delayed uploading of internal assessment marks on the student portal. The academic section was requested to ensure timely updates moving forward.

Faculty Grievance

1. Some faculty members reported frequent technical issues with smart classrooms, affecting the delivery of lectures. The committee recommended a maintenance audit of all smart classrooms.

2. Concerns were expressed about the irregularity in receiving timely administrative circulars. It was decided to streamline communication through a centralized digital notice

2. Some students expressed concern over insufficient Wi-Fi connectivity in hostels, particularly during evening hours. The committee recommended a technical review of the network infrastructure.
